## Pan-European Insurance Forum hands Chair role to Zurich CEO Mario Greco

Mario Greco, Chief Executive Officer (CEO) of Zurich Insurance Group, today assumes the role of Chair of the Pan-European Insurance Forum (PEIF), succeeding Thomas Buberl, CEO of the AXA Group. He will chair the forum for two years.
